Jai Shankar Dear Sādhaka-s,

Navarātri Utsava 2020 in Shrīmad Anantheshwar Temple will be observed from 17<sup>th</sup> October 2020 to 25<sup>th</sup> October 2020.

In view of the advisories and guidelines issued by the Central and the State Governments and with a view to ensure the safety of all devotees, all sādhaka-s are requested not to visit Viţtlā. This year we have kept the following Navarātri sevā-s:

### Navarātri Sevā – Rs. 3,820/- (Rupees Three Thousand Eight Hundred Twenty only)

This includes -

- a) Kunkumārchana Sevā, Saptashatī Pārāyana (all the days during Navarātri)
- b) Durgā Namaskāra, Devī Alaṅkāra Sevā (one day during Navarātri)
- c) Vhāntī during Pūrnāhuti (25th Oct 2020 Temple Chandikā Homa)

Though the seva counter at the temple will remain closed, the following modes of payment may be utilised.

#### [1] Remittance for sevā-s at Viţţlā:

- VII. Please note to write the name of the Sevā Kartā legibly on the counterfoil, for easy reconciliation.
- VIII. Sevā Kartā-s who are not able to access the aforesaid two modes, could also make a cash remittance to SVC Bank. The other details and process remain the same as given in (VI. & VII.) above. But care should be taken to write the name of the person depositing very clearly with Mobile number.
